PULSAR HELIUM ANNOUNCES WARRANT EXERCISE AND TVR

Pulsar Helium Inc. (AIM: PLSR, TSXV: PLSR, OTCQB: PSRHF) (“**Pulsar**” or the “**Company**”) notes that on January 23, 2026, 3,000 share purchase warrants – issued on January 10, 2025, pursuant to an advisory engagement, as announced on December 18, 2024 - have been partially exercised at a price of CAD\$0.57, and generated cash proceeds for the Company of CAD\$1,710.00.

Admission to AIM and Total Voting Rights

Application has been made to the London Stock Exchange plc for the admission of the 3,000 new common shares issued pursuant to abovementioned warrant exercise, to be admitted to trading on AIM. As announced on January 14, 2026, and due to an administrative error, application is also being made for a further 386,900 new common shares issued pursuant to stock option and warrant exercises, bringing the total number of new common shares being admitted to 389,900. Admission of all such new common shares, and the commencement of dealings, is expected to occur at 8.00 a.m. on or around January 29, 2026. The new common shares will rank *pari passu* with the Company's existing common shares.

On Admission, the total number of common shares in issue will be 170,730,466 with voting rights. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company's issued share capital pursuant to the Company's Articles.
